## Style St Albans 2018

### TERMS & CONDITIONS

Please find below the Terms and Conditions for the 'Style St Albans 2018' which all successful participants will be required to comply with throughout.

#### Definitions

- 'The Organiser' is St Albans BID 7 French Row, St Albans AL3 5DU.
- 'Fashion Participant' refers to any business selected to show garments during the Event.
- 'Hair or Beauty Participant' refers to any business selected to provide hair and beauty services in advance of the Event.
- 'Event' refers to Style St Albans, an event including two fashion shows performed on a catwalk on the evening of 19 October in the St Albans Museum + Gallery Assembly Rooms.

#### Rules of the Event

1. All applicants must agree to and sign the terms and conditions.
2. Successful Participants will be chosen based on the following:
  - a. Business premises are located within the BID area of St Albans.
  - b. Business premises predominantly retail fashion garments for Fashion Participants
  - c. Applicant has no overdue BID levy payments
  - d. Participants demonstrate passion for the campaign and a willingness to execute their contribution to the highest standard possible
3. Successful participants may not withdraw from the Event after the date **of Friday 17th August 2018**: failure to comply may result in exclusion from future activity and events.

#### Fashion Participants:

4. All garments included in the event are contributed at the risk of the Fashion Participant. The Organisers accept no responsibility for accidental damage, wear and tear or marks due to being used in two fashion shows (and rehearsals).
5. Selected outfits must be appropriate for public viewing, be available in the Participant's retail store by November 1 2018 and executed to the highest possible standard.
6. Participant must provide:
  - a. 10 complete outfits fitted to the models provided (variety of sizes will be booked);
  - b. Contact information with a named member of staff as the single point of contact with BID. This contact will coordinate fitting appointments with each model in the

first two weeks of October to determine which outfits they will wear between 24 September and 8 October;

- c. Clothes rail labelled with your business name, with the ten sets of garments clearly divided on the rail delivered to St Albans Museum + Gallery by 12noon on Friday 19 October;
- d. Printed photograph of each outfit on the model (taken before the event) to be used for rehearsal and running preparation;
- e. At least two members of staff to dress the models, prepare the outfits and undress after walking. Those two members of staff will be responsible for collecting all parts of each outfit back from each model after their run.

Hair or Beauty Participant:

7. Selected styles must be appropriate for public viewing and executed to the highest possible standard.
8. Participant must provide:
  - a. Hair (a secure and appropriate 'up do' or blowdry) or beauty services (full face of makeup) for between 5 and 10 models for the Event.
  - b. Contact information with a named member of staff as the single point of contact with BID. This contact will coordinate hair/beauty trial appointments with each allocated model in the first two weeks of October to determine which outfits they will wear between 24 September and 8 October;
  - c. Appointments for each model on Friday 19 October, so that all allocated models arrive (completed) at St Albans Museum + Gallery by 6pm on Friday 19 October;
9. All participants will be responsible for mitigating any risks posed by their participation in line with health and fire safety law.
10. If a participant is found to be in breach of these terms and conditions or environmental health standards, their participation will be revoked immediately.

### **Conditions**

1. The Organiser shall not be liable for i) loss of profits; or ii) loss of business; or iii) depletion of goodwill; or iv) loss of anticipated savings; or v) loss of goods; or vi) loss of contract or; vii) loss of use; or viii) loss or corruption of data or information; or ix) any special indirect, consequential or pure economic loss, costs, damage, charges or expenses.
2. The Organiser reserves the right to alter the arrangements of the event at any point without advance notice.
3. All Traders will comply with all current legislation, notices, orders, bylaws and shall comply with any restrictions, directions and conditions lawfully imposed by any public authority.

### **Contravention of Terms and Conditions**

If a participant is found to be in breach of these terms and conditions or environmental health standards, they may not be allowed to take part in the Event in the future.
